	Date and type of most recent maintenance: <ul style="list-style-type: none"> <li>Physical HVAC inspections are performed during routine filter changes and scheduled maintenance throughout the year.</li> <li>Filter Changes are performed 4 times a year (Quarterly)</li> <li>Mechanical systems are monitored daily through the D.D.C. Building Management System to ensure all HVAC equipment is operating at optimum performance.</li> </ul>
<b>RECOMMENDATION:</b> Increase supply of outside air	Yes/No: Yes
	Detail: <ul style="list-style-type: none"> <li>Maximized the amount of outdoor air supplied within the capacity of the heating systems (6 changes of outside air per hour).</li> <li>Increased run-times for ventilation through expanded HVAC operating hours.</li> <li>Mechanical Systems are set to “full occupancy mode” bringing in additional outside air throughout the day.</li> <li>Additional air exchanges in the morning before staff and students arrive.</li> </ul>
